Matters of Interest – Northumberland OPP Police Services Board

February 2025

ALNWICK/HALDIMAND:

On February 6, 2025, at around 9:15 p.m., OPP were patrolling County Road 9 in the Township of Alnwick/Haldimand when a passenger vehicle was observed travelling at 113 km/h in a posted 80 km/h limit.

The vehicle was stopped, and the officer made a Mandatory Alcohol Screening demand for the driver to provide a sample of breath. With the result, the individual was arrested and transported to a local police station for further tests. A search revealed approximately 25 grams of Cannabis available to the driver.

A 35-year-old from Warkworth, has been charged with:

- Operation while impaired – blood alcohol concentration (80 plus)
- Drive motor vehicle or boat with cannabis readily available
- Speeding

BRIGHTON:

On February 23, 2025, at approximately 1:32 p.m., the Northumberland OPP received a report of a theft from the Home Hardware in the Municipality of Brighton.

Through investigation, a 44-year-old female from the Township of Cramahe was arrested and charged with the following offences:

- Theft Under \$5,000- Shoplifting

CRAMAHE:

PORT HOPE:

On February 16, 2025, at approximately 12:45 a.m., police responded to a single vehicle collision on Cold Springs Camp Road. OPP arrived and following speaking with the uninjured driver, entered into an impaired operation investigation. An officer made an Approved Screening Device (ASD) demand and following a refusal to comply, the accused was taken into custody. The individual was transported to a local police station for further tests and the accused failed to comply with another demand for a sample of their breath.

A 39-year-old from Brantford, has been charged with:

- Failure or refusal to comply with demand – two counts
- Operation while impaired – alcohol and drugs
- Fail to comply with release order – other than to attend court.

In addition to a future court date, the driver was issued a 90-day licence suspension, and the vehicle was impounded for seven days.

TRENT HILLS:

On February 25, 2025, at around 12:10 p.m., the Northumberland OPP responded to a report of a student making threats and in possession of weapons at a high school. The school was placed on lockdown for the safety of all staff and students.

Upon arrival, officers took the student into custody without incident. There were no injuries reported, and police are not looking for anyone else in connection with this incident. The Northumberland OPP Crime Unit has been engaged to assist with the investigation.

Officers seized a handgun, ammunition and a number of edged weapons.

As a result, a 15-year-old male from Havelock, was charged with the following Criminal Code offences:

- Carry firearm, weapon, prohibited device or ammunition in careless manner
- Possession of weapon for dangerous purpose – two counts
- Carrying concealed weapon
- Unauthorized possession of a prohibited or restricted firearm
- Knowledge of unauthorized possession of firearm
- Possession of loaded prohibited or restricted firearm
- Uttering threats - cause death or bodily harm.

The accused was held in custody and is scheduled to appear before the Ontario Court of Justice in Cobourg on a later date. The identity of the accused shall be withheld as it is protected under the Youth Criminal Justice Act.
